**ORDER:**

In the G.O's 1<sup>st</sup> & 2<sup>nd</sup> read above, Government have fixed tuition fee for GNMC, MPHWF, DMLT and other Paramedical Courses and B.Sc (Nursing), P.B.B.Sc (Nursing), B.Sc (MLT), BPT, MPT courses for the block period of 2010-11, 2011-12 and 2012-13.

In the letter 3<sup>rd</sup> read above, the Administrative Officer, Admission & Fee Regulatory Committee, has informed that the AFRC relating to fee fixation in its meeting held on 19/7/2013 has resolved to postpone the fixation of tuition fee for Private Un-Aided B.Sc. (Nursing), Post Basic B.Sc., M.Sc. (Nursing) B.Sc. (MLT), BPT & MPT, GNMC, DMLT and MPHWF (F) Courses in Private Un-Aided Nursing & Para Medical Institutions till the next academic year i.e., 2014-15 and the existing tuition fee structure for the B.Sc. (Nursing), Post Basic B.Sc., M.Sc. (Nursing), B.Sc. (MLT), BPT & MPT, GNMC, DMLT and MPHWF (F) Private Un-Aided Nursing & Para Medical Institutions be retained for this academic year i.e., 2013-14".

After careful examination of the proposals of the Admission and Fee Regulatory Committee relating to the fee structure for GNMC, MPHWF, DMLT and other Paramedical Courses and B.Sc (Nursing), P.B.B.Sc (Nursing), B.Sc (MLT), BPT, MPT courses, Government hereby order that the existing Fee structure as ordered in G.O's 1<sup>st</sup> & 2<sup>nd</sup> read above, for GNMC, MPHWF, DMLT and other Paramedical Courses and B.Sc (Nursing), P.B.B.Sc (Nursing), B.Sc (MLT), BPT, MPT courses in the state be retained for the Academic year 2013-2014.

4. The Director of Medical Education / Registrar, Dr.NTR University of Health Sciences, Vijayawada/ Secretary, A.P.Para Medical Board shall take necessary action in the matter accordingly.
