ORDER:

In the G.O. first read above, rules have been issued on Andhra Pradesh General Nurse Training Institutions (Admission into General Nurse Training and Grant of permission to Private schools of Nursing) Rules, 1997. In the G.O. 2nd read above, amendment has been made to the said rules, prescribing rates of fee for students of Schools of Nursing for clinical training in Government hospitals as specified below:-

- 1) Rs.25/- per student upto one week;
 - 2) Rs.100/- per month per student upto three months;
 - 3) Rs.500/-per student for imparting training above three months to six months.
 - 4) Above six months Rs.1,000/- per student for the period and per academic year;
2. Government after review of the matter have decided to revise the clinical attachment fee for both B.Sc. (Nursing) students and General Nurse Midwifery students to private Nursing Colleges and Nursing schools in Government Hospitals and to dispense with the clinical attachment for one week and three months. Separate orders will be issued in respect of B.Sc. (Nursing) courses.
3. Accordingly, the following Notification will be published in the next issue of Andhra Pradesh Gazette:-

NOTIFICATION

In exercise of the powers conferred by Section 99 of the Andhra Pradesh Education Act, 1982 (Act 1 of 1982), the Governor of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh General Nurse Training Institutions (Admission in to General Nurse training and grant of permission to Private Schools of Nursing) Rules, 1997 issued in G.O.Ms.No.313, HM&FW(M2)

Department, dated 16-08-1997 and as amended from time to time:-

AMENDMENT

In the said rules,

For the existing rule 11, the following shall be substituted, namely:-

"11. CLINICAL ATTACHMENT FEE:"

(i) The Nursing Institution which require clinical attachment for the purpose of imparting training to its students in Government hospitals, shall have to pay a fee as specified below:-

1) Rs.500/- (Rupees five hundred only) per student in General Nurse Midwifery course for a period not exceeding six months;

2) Rs.1,000/- (Rupees one thousand only) per student both in General Nurse Midwifery course for a period above six months and below one year;

However, Government reserve the right to revise this fee from time to time and;

(ii) Permission for affiliation of a Private Nursing School to any Government Hospital shall be given only by the Government and no superintendent of the hospital or any other authority subordinate to the Government is authorised to issue such permission."
