## ORDER:

In the G.O.1<sup>st</sup> read above, orders were issued enhancing the stipends of Student Nurses @ Rs.500/- per month for 1<sup>st</sup> year, Rs.600/- per month for 2<sup>nd</sup> year, Rs.700/- per month for 3<sup>rd</sup> year. In the G.O.2<sup>nd</sup> read above, orders were issued enhancing the stipend of students Nurses of 4<sup>th</sup> year B.Sc. (Nursing) to Rs.800/- per head per month w.e.f. 30-4-1999.

- In the letter 3<sup>rd</sup> read above, DME has reported that A.P. Government Nurses Association has demanded for enhancement of stipends to the Nursing Students @ Rs.1500/- per month for 1<sup>st</sup> year student nurse, Rs.1700/- per month for 2<sup>nd</sup> year student nurse, Rs.1900/- per month for 3<sup>rd</sup> year student Nurse and Rs.2,200/- per month for Internees for 6 months.
- 3. In the memo 4<sup>th</sup> read above, DME was informed that in the proposals sent to Government, it is recommended enhancement of stipend to GNM students alone ignoring the B.Sc. Nursing students while calculating the financial implications on increase of stipend. The Director of Medical Education, A.P., Hyderabad was therefore requested to re-examine the financial implications duly taking into account the number of B.Sc. Nursing students and indicate the financial implications on account of increase of stipend for the 4 year course.
- 4. In the letters  $5^{th}$  and  $6^{th}$  read above, the DME has furnished the following expenditure towards enhancement of stipend to GNM students:

- 5. The DME has reported that expenditure as per present rate of stipend paid is Rs.98,49,600/- per annum and as per enhanced rate of stipend is Rs.3,39,26,400/- per annum. Additional expenditure on account of proposed enhancement of stipend to the GNM students works out to Rs.2,40,76,800/-per annum. (ie.,Rs.3,39,26,400 Rs.98,49,600/-).
- 6. The DME has also proposed for enhancement of stipends towards 320 B.Sc. (Nursing) students for 1<sup>st</sup> year and 220 existing students each for 2<sup>nd</sup> to 4<sup>th</sup> year in 6 Govt. Colleges of Nursing in the state as stated below:-

- 7. The DME has reported that present expenditure towards stipend is Rs. 74.64,000/- per annum and the proposed expenditure towards enhanced rate of stipend works out to Rs. Rs.2,10,72,000/- Thus additional expenditure towards stipends to the students of B.Sc., (Nursing) works out to Rs.1,36,08,000/- per annum of Govt. Nursing Colleges in the state.
- 8. The DME has therefore requested to issue necessary orders in the matter keeping in view the strike notice given by the A.P.Student Nurses Association of GNM.
- 9. Government after careful examination of the matter has decided to accept the above proposal of the DME accordingly hereby enhance stipends to student Nurses w.e.f. 01-01-2010 as indicated below:
